Comprehensive Board-Adopted Drug-Testing Policy

The NACCI and Blount County Board of Education drafted a drug-testing policy which was used as a “working” document to take to the community. It contained these components:

- Eligibility for Testing;
- Confidentiality Procedures;
- Testing Procedure;
- Collection of samples;
- Notification of testing results;
- Consequences-First, Second and Third Positive
- Appeal Procedure;
- Pupil Consent to Test Form;
- Drop Form; and
- Legal Assurance

Implementation

We submitted our grant application with an engaged community and a comprehensive, board-adopted drug-testing policy. Consequently, implementation has been very smooth. The policy directs implementation.



Implementation – What Has Worked Well Drug-Testing Device

Drug-Testing Device

Rationale for Oral Fluid Testing

- Less invasive than other testing methods;
- Does not require a private bathroom to collect the specimen;
- Takes less time to test a higher number of students; and
- Less chance for specimen tampering or adulteration to occur

Implementation – What Has Worked Well

Evaluation

We use a community-based, participatory evaluation component.



Implementation - Challenge

We drug-test three (3) groups of students:

- Students who participate in any athletics;
- Students who participate in competitive, extra-curricular activities and/or school clubs which have competitive components; and
- Students who elect to voluntarily participate in the School-Based Student Random Drug and Alcohol Testing Program who provide consent and their parents provide consent
